> I am writing to you as a local sports representative, to ask you to
 > contribute to shaping the future of sports facilities in the city.

>

> The Local Development Framework is a suite of documents which will replace
 > the current local plan. One of the documents in this framework is the
 > Allocations Development Plan Document, this document will allocate areas
 > of land for certain types of usage, e.g. residential, employment or
 > Leisure. The Council's Strategic Development Unit are currently carrying
 > out consultation on the allocations document, hoping to identify now, what
 > the city's future needs are. It is important that we take this opportunity
 > to ensure that the future land needs for sport are recognised and
 > reflected in the LDF.

>

> I am sure you have all been invited to participate in Active York (the
 > city's Sport & Active Leisure Partnership), and those of you who have, may
 > know that the council holds a sports project portfolio on behalf of Active
 > York. This portfolio contains over 50 capital and revenue based projects
 > that have come to Active York's attention. Any projects in the portfolio
 > that require additional land will be included in the comments of the Sport
 > & Active Leisure team. However we only have information about current or
 > imminent projects.

> The LDF documents will be living documents but with an expected life span
 > of approximately 20 years, so it is important that the longer term needs
 > for sports land are reflected. >

>

> Please consider your clubs long term needs/ plans and if these include any
 > expansion or land acquisition let me know about them, so that the feedback
 > from Sport & Active Leisure to City strategy can be as comprehensive as

> possible. please describe your intentions and give a location for the land
> that would be most appropriate (if it exists), the location can be in the
> form of grid references, a description, or a general location. You may
> have been contacted directly by the Council's Strategic Development Unit,
> and responded with your plans, but please also let me know so that the
> Council's Sport & Active Leisure Team's response can reflect the needs of
> the city as a whole.

>
> This consultation is a rare opportunity to have your plans recognised, so
> let's try to make a difference to the future of the city's sporting
> facilities. If we plan collectively now we should be able to make sport a
> key element of York's spatial future.

> (especially if you want to include copies of plans) or on the number
> below, by Wednesday 14 May.
